SOCIAL MEDIA CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of Canyon Distributing Company located at 10190 E Valley Rd, Prescott Valley, AZ 86314, by sending a self-addressed, stamped envelope to the above address.

Canyon Distributing Company will conduct the **CANYON DISTRIBUTING COMPANY, CORONA AND CORONA LIGHT “#FINDYOURBEACHAZ” SOCIAL MEDIA** Contest (the “Contest”) substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This contest is open only to legal U.S. Arizona residents, excluding states outside of Arizona, age twenty-one (21) years or older at the time of entry with a valid date of birth and who reside in the Canyon Distributing’s Designated Market Area (“DMA”) as defined by Canyon Distributing Company service areas, who have not won a prize from Canyon Distributing Company in the last **90 days** or a prize valued at \$500 or more in the **180 days**, and whose immediate family members or household members have not won a prize from Canyon Distributing Company in the last **90 days** or a prize valued at \$500 or more in the **180 days**. **Void where prohibited by law.** Employees of Canyon Distributing Company, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other beer distributors serving the Canyon Distributing Company DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term “household members” refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Limit one (1) entry per person per day per email address.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. 4. **Winners Selection.** On or about 2:00pm Arizona Mountain Time on Tuesday, June 4, 2019; Tuesday; August 6, 2019; Tuesday, October 8, 2019; Tuesday, December 17, 2019. Canyon Distributing Company will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Canyon Distributing Company during the Contest Period. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
